In the Matter of Resuming Family Law Trials Postponed by Coronavirus/COVID-19)

The Iowa Judicial Branch continues to carefully monitor the public health situation created by the Coronavirus/COVID-19 outbreak and its impact on Iowa’s justice system. The judicial branch is committed to providing access to justice for all Iowans while balancing the need to take measures to reduce the spread of the virus. In response to the public health recommendations regarding social distancing and limitations on larger gatherings of people, the supreme court continued all family law trials to a later date. Family law cases comprise a significant part of the civil docket and of greatest concern are those cases in which children are waiting for final custody arrangements.

As the Iowa Judicial Branch continues planning to resume family law trials, it seeks to develop policies and procedures to ensure parties’ fundamental rights while protecting the health and safety of parties, court staff, attorneys, judges, and all Iowans who access the courthouse.

The supreme court establishes the Jumpstart Family Law Trials Task Force to develop temporary policies and procedures for family law trials resuming following the COVID-19 postponements. The following individuals are appointed to the Task Force:


